1. Pursuant to Public Resources Code 21167.6(b), Petitioner elected to prepare the record of proceedings. Petitioner sent a Public Records Act request to the County of Shasta seeking copies of all documents that constitute the administrative record pursuant to Public Resources Code section 21167.6(e). The County has complied with the PRA request and has provided to Petitioner the documents that constitute the administrative record in this matter.

2. On or about April 30, 2024, Petitioner provided the County Counsel's Office a

3. On or about May 3, 2024, staff with the County Counsel's office informed Petitioner's Counsel that the document was not accessible on dropbox. Petitioner's counsel then copied the draft administrative record on to a flash drive and sent the record to the County Counsel's Office via Federal Express.

4. On May 20, 2024, County Counsel informed Petitioner's counsel that there were significant errors in the transcripts for the Planning Commission meeting and the Board of Supervisors' meeting and that the County could not resume its review of the administrative record until corrected transcripts were provided.


5. On June 3, 2024, Petitioner's counsel received back the corrected transcript and is reviewing them for accuracy. Petitioner will provide the County a corrected transcript by Friday, June 7, 2024 via dropbox and by June 10, 2024 via Federal Express.

6. Upon the County's review of the draft administrative record, Petitioner will make the requested changes and finalize the administrative record for the certification. Petitioner does not have an estimate of the amount of time it will take for the County to review the administrative record.


